All of Government Lots 5, 6, 7, 8, and 9 in Section 21, T34N., R2E., W.M., EXCEPT that portion which lies between the line of ordinary high tide and a line parallelling such ordinary high tide and two hundred (200) feet horizontally landward therefrom; AND ALSO EXCEPT that portion lying south and west of the following described lines: Beginning at the intersection of the east line of said Government Lot 7 with its southerly ordinary high tide, thence north along said east line 475 feet, thence west to the line of ordinary high tide.
