I, Rick Grimstead, Sheriff of Skagit County, State of Washington, do hereby certify that an ORDER OF SALE did issue out of the Superior Court of SKAGIT County; Washington, on August 28, 2008 and extended October 31, 2008, upon a judgment rendered in Superior Court of SKAGIT County, Washington on August 14, 2008, in favor of CASCADE RIVER COMMUNITY CLUB INC., for the sum of nineteen thousand, three dollars and eighty-eight cents (\$19,003.88).

The ORDER OF SALE, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on August 28, 2008, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the ORDER OF SALE.
