MEMORANDUM OF SUBLEASE

THIS MEMORANDUM OF SUBLEASE, dated as set forth below, between SKAGIT VALLEY MEDICAL CENTER, INC., P.S., a Washington Professional Service Corporation (hereinafter "SVMC") and THE COFFEE DOCTOR, INC., a Washington Corporation, (hereinafter "Subtenant").

SVMC and Subtenant entered into a Sublease Agreement, dated November 1, 2008 and executed on May 28, 2009 pursuant to which SVMC subleased to Subtenant and Subtenant subleased from SVMC its current space commonly known as 1400 E.
