DEED OF TRUST. Lender and Grantor have entered into a Deed of Trust dated December 6, 2006 (the "Deed of Trust") which has been recorded in Skagit County, State of Washington, as follows:

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in Skagit County, State of Washington:

MODIFICATION. Lender and Grantor hereby modify the Deed of Trust as follows:

Deed of Trust now secures Promissory Note dated April 1, 2010 in the amount of \$3,434,667.50. This Note is a renewal and replacement of Promissory Note dated December 30, 2008 in the original amount of \$4,036,500.00. All references in the loan documents to the old Note shall be deemed to be a reference to the new Note.

The Deed of Trust is amended to add the real property legally described herein as Parcels "E" through "H" to the definition of "Real Property" under the Deed of Trust. Grantor irrevocably grants, bargains, sells and conveys to the Trustee under the Deed of Trust and its successors and assigns in trust, with power of sale and with right of entry and possession as provided herein, all Grantor's estate, right, title, interest, claim and demand, now owned or hereafter acquired, in and to the New Parcels, and all "Property" as defined in the Deed of Trust, including all such Property associated with the New Parcels.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

COUNTERPARTS. This Agreement may be executed in a number of identical counterparts and by each party on a separate counterpart. If so executed, all of such counterparts shall collectively constitute one agreement.

GRANTOR ACKNOWLEDGES HAVING READ ALL THE PROVISIONS OF THIS MODIFICATION OF DEED OF TRUST AND GRANTOR AGREES TO ITS TERMS. THIS MODIFICATION OF DEED OF TRUST IS DATED APRIL 1, 2010.
