I, Rick Grimstead, Sheriff of Skagit County, State of Washington, do hereby certify that a AMENDED WRIT OF EXECUTION IN FORECLOSURE did issue out of the Superior Court of SKAGIT County, Washington, on April 17, 2009, upon a judgment rendered in Superior Court of SKAGIT County, Washington on November 17, 2008, in favor of WASHINGTON MUTUAL BANK, for the sum of two hundred nine thousand, one hundred eighty-eight dollars and eleven cents (\$209,188.11).

The AMENDED WRIT OF EXECUTION IN FORECLOSURE, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on April 23, 2009, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the AMENDED WRIT OF EXECUTION IN FORECLOSURE.
