X. 



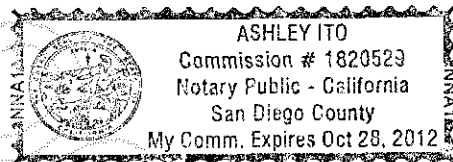
