## TRUSTEE'S DEED

This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust between Guy Michaud, and unmarried person, as Grantor, to Washington Services, Inc., A Washington Corporation as Trustee, and Washington Federal Savings as Beneficiary, dated September 20, 2007 recorded on September 21, 2007 as No. 200709210076. Said Deed of Trust was modified on February 10, 2010.
- 2. Said Deed of Trust was executed to secure, together with other undertakings, the payments of a promissory note according to the terms thereof, in favor of Washington Federal Savings and to secure any other sums of money which might become due and payable under the terms of said Deed of Trust.

- Default having occurred in the obligations secured and/or covenants of the Grantor as set forth in "Notice of Trustee's Sale" described below, which by the terms of the Deed of Trust made operative the power to sell, the thirty-day advance "Notice of Default" was transmitted to the Grantor, or his successor-in-interest, and a copy of said Notice was posted or served in accordance with law.
- Washington Federal Savings being then the holder of the indebtedness secured by said 5. Deed of Trust, delivered to said Trustee a written request directing said Trustee to sell the described property in accordance with law and the terms of said Deed of Trust.
