MODIFICATION OF DEED OF TRUST

PARCEL A: Lots 1-7, inclusive and the West 25 feet of Lot 8, Block 2, 'C.W.GREIST'S PLAT OF as per plat recorded in Volume 3 of Plats, page 94, records of Skagit County Washington.

PARCEL B: The East 200 feet of the tract labeled "Reserved for Park", on the Plat of "C.W. GRIEST'S PLAT OF GRASMERE" as per plat recorded in Volume 3 of Plats, page 94 of records of Skagit County, Washington; said tract appeared on a prior deed as the "East 200 feet of Park Block 2", TOGETHER WTH those portions of vacated Park Street adjoining which upon vacation reverted to said premises by operation of law; EXCEPT that Westerly portion, if any, of the above described property lying within the right-of-way commonly known as the Concrete Road.

Nothing in this Modification shall constitute a satisfaction of the Promissory Note secured by the Deed of Trust.
