EXHIBIT "A" STATUTORY WARRANTY DEED

Legal Description:

That portion of Block 136, "FIRST ADDITION TO BURLINGTON, SKAGIT COUNTY, WASHINGTON," as per plat recorded in Volume 3 of Plats, page 11, records of Skagit County, Washington, more particularly described as follows: All of Lots 7, 8, 9 and 10 except the three portions described as follows:

- Beginning at the Southwest corner of said Lot 7; thence (1)North 0°16' 30" East along the West line of said Lot 7 a distance of 75.19 feet to the beginning of a tangent curve to the right having a radius of 25.00 feet; thence along the arc of said curve through a central angle of 89°33'45" a distance of 39.08 feet; thence North 89°50'15" East a distance of 75.19 feet; thence South 0°16'30" West a distance of 100.00 feet to the South line of said Lot 7: thence South 89°50'15" West a distance of 100.00 feet to the point of beginning.
- (2) Commencing at the Northwest corner of said Lot 9; thence South 0°16' 30" West along the West line of said Lot 9 a distance of 18.29 feet to the true point of beginning. Thence continue South 0°16' 30" West along said West lot line a distance of 74.81 feet to the beginning of a tangent curve to the left having a radius of 25.00 feet; thence along the arc of said curve through a central angle of 90°26'15" a distance of 39.46 feet; thence North 89°50'15" East a distance of 74.81 feet; thence North 0°16'30" East a distance of 100.00 feet; thence South 89°50'15" West a distance of 100.00 feet to the true point of beginning.
- (3) The West 100 feet of Lot 10 and the West 100 feet of the North 18.29 feet of Lot 9.
