STATUTORY WARRANTY DEED

Legal Description:

That portion of Block 136, "FIRST ADDITION TO BURLINGTON, SKAGIT COUNTY, WASHINGTON," as per plat recorded in Volume 3 of Plats, page 11, records of Skagit County, Washington, more particularly described as follows:

All of Lots 7, 8, 9 and 10 except the three portions described as follows:

(1) Beginning at the Southwest corner of said Lot 7; thence North 0°16' 30" East along the West line of said Lot 7 a distance of 75.19 feet to the beginning of a tangent curve to the right having a radius of 25.00 feet; thence along the arc of said curve through a central angle of 89°33'45" a distance of 39.08 feet; thence North 89°50'15" East a distance of 75.19 feet; thence South 0°16'30" West a distance of 100.00 feet to the South line of said Lot 7; thence South 89°50'15" West a distance of 100.00 feet to the point of beginning.

(2) Commencing at the Northwest corner of said Lot 9; thence South 0°16' 30" West along the West line of said Lot 9 a distance of 18.29 feet to the true point of beginning. Thence continue South 0°16' 30" West along said West lot line a distance of 74.81 feet to the beginning of a tangent curve to the left having a radius of 25.00 feet; thence along the arc of said curve through a central angle of 90°26'15" a distance of 39.46 feet; thence North 89°50'15" East a distance of 74.81 feet; thence North 0°16'30" East a distance of 100.00 feet; thence South 89°50'15" West a distance of 100.00 feet to the true point of beginning.

(3) The West 100 feet of Lot 10 and the West 100 feet of the North 18.29 feet of Lot 9.
