Assignee hereby agrees to defend, indemnify and hold Assignor harmless from and against any and all claims, suits, obligations, liabilities and damages, including reasonable attorneys' fees, accruing or arising in any way and at any time under the Sublease on or after the Assignment Date. Assignor hereby agrees to defend, indemnify and hold Assignee harmless from and against any and all claims, suits, obligations, liabilities and damages, including reasonable attorney's fees, accruing or arising in any way and at any time under the Sublease prior to the Assignment Date.
