1. A site visit was conducted on July 27, 2011 by Skagit County Building Inspector Bob VanderLinden. Mr. VanderLinden observed several lean-to type additions to an existing building all constructed without building permits.

Part 4 Conclusions of Law

The Administrative Official has found you in violation of the following provisions of Skagit County Code:

1. <u>SCC 15.04 and IBC 105.1</u>. Construction shall not occur without first making application and obtaining the required building permit. Your construction of several lean-to type additions without a permit violates these code sections.

Part 5 Corrective Action

You are hereby requested to take the following action to abate the above violations:

- Provide a completed application, including fees, for a building permit for your structure by September 28, 2011, and obtain the required permit, or
- 2. Remove or dismantle the lean-to additions.

Failure to remedy the violation may result in issuance of a formal Notice and Order to Abate with associated fines, and may include referral to the Prosecuting Attorney for further enforcement action including commencing a court action for criminal and civil penalties.

Part 6

Disclosures
