The Undersigned subordinator and owner agree as follows:

- 1. BOEING EMPLOYEES' CREDIT UNION referred to herein as "subordinator", is the owner and holder of a mortgage dated **June 11, 2010** which is recorded in volume of Mortgages, page , under auditor's file no. **201006210123** records of **Skagit** County.
- 2. BOEING EMPLOYEES' CREDIT UNION referred to herein as "lender" is the owner and holder of the mortgage dated March 19, 2012 executed by Steven B Burton and Jill Burton (which is recorded in volume of Mortgages, page under auditor's file no. 201203260070 records of Skagit County) (which is to be recorded concurrently herewith.)
- 3. Steven L Burton and Jill Burton referred to herein as "owner" is the owner of all the real property described in the mortgage identified above in Paragraph 2.
- 4. In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its mortgage and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of his/her mortgage, identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above, and all advances or charges made or accruing thereunder, including any extension or renewal thereof.
