This Memorandum of Termination of Lease ("Lease Termination") is made as of September 7, 2012 (the "Effective Date"), by and between DVF MANAGEMENT CORPORATION, formerly Draper Valley Farms, Inc., a Washington corporation ("Landlord") and DRAPER VALLEY HOLDINGS LLC, a Delaware limited liability company ("Tenant").

RECITALS

WHEREAS, Landlord and Tenant previously entered into that certain Lease Agreement dated as of September 6, 2007 ("Original Lease"), as amended by that certain First Amendment to Lease Agreement dated as of December 1, 2008 ("First Amendment") (collectively, the "Lease"), whereby Landlord leased to Tenant, and Tenant accepted and leased from Landlord those certain premises (as defined in the Original Lease) located at 17413 State Route 20, Burlington, Washington 98233 and more particularly described in Exhibit A attached hereto ("Premises").

WHEREAS, Tenant exercised its option to terminate the Lease effective on September 7, 2012, by written notice to Landlord dated August 24, 2010 and delivered to Landlord in accordance with Section 3(b) of the Original Lease.

WHEREAS, Landlord and Tenant wish to confirm that (1): Tenant has vacated the Premises and delivered the keys to the Premises to Landlord, and (2) the Lease terminated on September 7, 2012, by executing this Memorandum of Termination of Lease for recording with the recording official of Skagit County Washington.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Landlord and Tenant agree as follows:

- Recitals and Capitalized Terms. The Recitals set forth above are hereby incorporated into the body of this Lease Termination and the capitalized terms used but not defined herein shall have the same meaning as are ascribed to those terms in the Lease.
- Termination of Lease. The Lease terminated on September 7, 2012 and the Landlord is authorized and directed to present the fully executed original of this Lease Termination to the recording official of Skagit County Washington for recording.
