THIS AGREEMENT (the "Agreement"), is made the date set forth below, by and between PPR CASCADE LLC (hereinafter "Grantor"), and the CITY OF BURLINGTON, a Washington municipal corporation (hereinafter, "Grantee").

The Grantor, for and in consideration of a mutually beneficial donation, hereby temporarily grants and conveys to the Grantee, the right, privilege, and easement over, upon, and across the hereinafter described lands for the purpose of improving the three Burlington Boulevard intersections with Cascade Mall Drive, and any related construction activities including the right to locate equipment, and materials during construction.

The Grantor's donation of property rights to the City of Burlington is made voluntarily and with full knowledge of its entitlement to receive just compensation. Grantor hereby waives the City of Burlington from obtaining an appraisal of the acquired property rights.

The anticipated areas of construction are shown in the attached exhibits A, B, and C and the easement area is further described as:

Lot 6 of Cascade Mall Binding site plan recorded as auditor file #8910190065.

The GRANTEE when exercising its rights to install improvements in the easement area, shall notify GRANTOR of the intended activity and shall restore the easement area to a neat and proper order. This temporary easement will terminate upon completion of construction.

GRANTEE, and its successors or assigns, will indemnify, defend, and save GRANTOR and its successors or assigns, harmless from, any damage or injury, either to persons or personal property, sustained by GRANTOR, its contractors, invitees, agents, employees or others, which damage or injuries are caused by any act or omission of GRANTEE, its agents, contractors, invitees or employees, originating from any activity, work, or things done, permitted or suffered by GRANTOR within the easement area.


