- GRANTOR. The undersigned Grantor, FRANCES ARLENE NELSON (a/k/a Arlene D. Nelson). individually as the surviving spouse and as the duly appointed, qualified and acting Personal Representative of the Estate of Robert W. Nelson, Deceased.
- 2. ESTATE. ROBERT W. NELSON ("Decedent") died on April 19, 2013, and FRANCES ARLENE NELSON (a/k/a Arlene D. Nelson) was appointed Personal Representative on May 21, 2013, in the State of Washington Superior Court for King County in Cause No. 13-4-10524-9 SEA ("probate proceedings").
- NONINTERVENTION POWERS. By Order of Solvency entered on September 13, 2103, in the probate proceedings, Grantor was authorized to settle the Estate without further court intervention or supervision.
- DESCRIBED PROPERTY. Included among the property of the Estate of Robert W. Nelson, deceased, was real property located in Skagit County, Washington, which is legally described as follows ("Described Property"):
