This Agreement is being executed pursuant to the terms of that certain Loan Agreement dated as of June 19, 2008, between Grantor and Beneficiary, as amended by that certain Amended and Restated Loan Agreement of even date herewith (collectively, and as amended, restated or supplemented from time to time, the "Loan Agreement"). Pursuant to the Loan Agreement, the Grantor is or hereafter shall be justly indebted in the aggregate original principal amount of NINETEEN MILLION THREE HUNDRED EIGHTY-FIVE THOUSAND EIGHT HUNDRED TWENTY-SEVEN AND 49/109 US DOLLARS (\$19,385,827.40) (the "Loan"), as evidenced by one or more promissory notes from the Grantor to Beneficiary, in such aggregate amount and of even date herewith, bearing interest as set forth therein and all successive extensions and renewals of the Obligations represented thereby (said notes, as presently constituted and as they may hereafter be amended, extended, renewed or consolidated, together with any and all

notes that may hereafter be given in substitution therefor, being hereinafter referred to as the "Note" or the "Notes").

This Agreement is made to secure and shall secure the prompt payment and performance of the Notes, including all the Obligations set forth in Section 1.1 of the Deed of Trust. This Agreement and the transactions described herein are not intended and shall not be construed to impair the validity, priority or enforceability of the Deed of Trust and are not intended and shall not be construed as a novation of any of the Secured Obligations nor to release or change the liability of any person who may be primarily or secondarily liable for the Secured Obligations. Grantor hereby affirms and ratifies each and every provision of the Deed of Trust as amended by this Agreement and hereby affirms and ratifies each of the Loan Documents.

This Agreement may be signed in counterparts, all of which together shall constitute one and the same original.
