NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned Subordinator and Owner agrees as follows:

1. Whidbey Island Bank, referred to herein as "Subordinator," is the owner and holder of a mortgage/deed of trust dated 2/21/12, which is recorded under Recording No. 201202230029, Records of Skagit County.
2. Citibank, N.A., referred to herein as "Lender" is the owner and holder of a mortgage/deed of trust not to exceed the amount of \$145,450.00, dated MAY 12, 2014, executed by Ernest & Diane Olmsted, (which is recorded in Volume \_\_\_\_\_ of Mortgages, Page \_\_\_\_\_ under Auditor's File No. \_\_\_\_\_ Records of Skagit County) (which is to be recorded concurrently herewith).
3. Ernest & Diane Olmsted, referred to herein as "Owner," is the owner of all the real property described in the mortgage/deed of trust to be identified above in Paragraph 2.
4. In consideration of benefits to Subordinator from Owner, receipt and sufficiency of which is hereby acknowledged, and to induce Lender to advance funds under its mortgage/deed of trust and all agreements in connection therewith, the Subordinator does hereby unconditionally subordinate the lien of his mortgage/deed of trust, identified in Paragraph 1 above to the lien of Lender's mortgage/deed of trust, identified in Paragraph 2 above, and all advances or charges made or accruing thereunder, including any extension or renewal thereof.
