The use easement agreement herein granted for garage is limited to a triangle 8' by 8' by 3' approximately as shown on the attached record of survey and being approximately the Southwestern most corner of the garage.

In addition – this easement agreement herein granted is for use of southeast corner of the property at 516 Washington St., as portion for a garage serving the 518 Washington St. property. The use easement agreement herein granted for garage is limited to a strip 5.42 feet in width, approximately as shown on the attached record of survey and being approximately the southeastern most 108 square feet of lot 14, block 17, syndicate addition to the Town of La Conner.

If the Garage is damaged/destroyed, the structure will be rebuilt without any encroachments on the above easements. The owner of 518 Washington St. will also have access to go on to the West and South properties for the purpose of maintenance, such as painting, cleaning gutters, etc.


