Simington by deed dated May 26, 1941 and recorded May 27, 1941 in Volume 184 of Deeds, page 157, records of said county; thence South along the East line of said Simington tract to the North line of the State Highway; thence Easterly along the North line of the State Highway 12.6" thence North parallel with the East line of the Simington Tract 105 feet; thence Easterly in a straight line to the Point of Beginning, EXCEPT the right of way of the Backus Road along the East side of said premises, AND ALSO beginning on the North line of the State Highway at the Southeast corner of that certain tract conveyed to C.M.
