

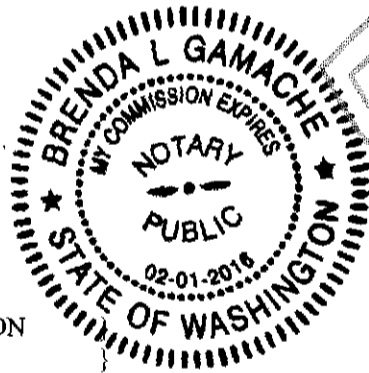
SATISFACTION OF LIEN


