

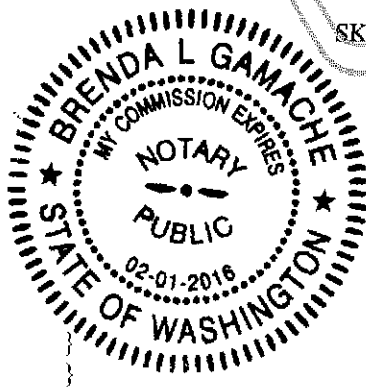
SATISFACTION OF LIEN
