AMENDMENT TO DEED OF TRUST

This **Amendment** amends that certain Deed of Trust as amended ("**Deed of Trust**") dated July 2, 2008, made by J & J Samish, LLC, a Washington limited liability corporation ("**Grantor**") as Grantor, to Columbia State Bank as successor in interest to the Federal Deposit Insurance Corporation as receiver for Summit Bank ("**Bank**") as Beneficiary, recorded July 11, 2008, in Skagit County, Washington, under recording number 200807110085, and constituting a first lien encumbrance on the real and personal property and fixtures described in the Deed of Trust.

The Deed of Trust secured obligations set forth therein, and obligations of Grantor to Bank under the Promissory Note between Grantor and Bank dated July 2, 2008, as subsequently amended ("**2008 Loan**"). The 2008 Loan has now been modified by the Forbearance Agreement between Grantor, Manzanita Properties, LLC, Jansen, Inc., Grant Jansen, and Al Jansen (collectively, "**Borrowers**") and Bank dated as of June 16, 2015, evidencing indebtedness in the principal amount of \$513,537.03.

The definition of "Note" contained in the Deed of Trust is hereby amended and replaced to state the following in full:

Note. The word "Note" means the promissory note dated July 2, 2008, in the original principal amount of \$614,235.62 from Grantor to Lender together with all renewals, extensions, modifications, refinancings, consolidations and substitutions of the promissory note or agreement, including but not limited to the Forbearance Agreement dated June 18, 2015, for indebtedness in the current principal amount of \$513,537.03 between Borrowers and Bank.

This Amendment may be executed in counterparts, each of which when so executed shall be deemed an original, but all such counterparts together shall constitute but one and the same agreement.
