This Memorandum of Lease Assignment is made this 24th day of September., 2015 between CULTUS MOUNTAIN MEDICAL INVESTMENTS LLC, a Washington limited liability company ("Landlord"), and PHYSICIAN'S CARE FAMILY MEDICINE, INC., P.S., a Washington professional services corporation ("Assignor/Tenant") and Skagit County Public Hospital District No. 1, a Washington public hospital district, D/B/A Skagit Regional Health ("Assignee/Tenant").

1. Lease Assigned and Term. Pursuant to a Lease Agreement dated June 15, 2007, memorandum of which was recorded under Skagit County Auditor's File No. 200804030158; which Lease Agreement was amended and restated by an instrument dated August 17, 2015 and made effective January 1, 2014, a memorandum of which is recorded under Skagit County Auditor's File No. 201509080093 (collectively the "Lease"), Landlord has leased to Assignor/Tenant the real property located in Skagit County, described in Appendix "A" hereto, for a period of fifteen (15) years beginning January 1, 2014 and terminating on December 31, 2028 at 11:59 p.m., unless sooner terminated pursuant to any provision of the Lease. The Lease also includes one (1) option to extend the term of the lease for five (5) years. The parties hereby incorporate all other terms and conditions of the Lease.

- Assignment. By the Assignment and Amendment of Lease and Consent Thereto dated the 24th day of September, 2015 (the "Instrument"), the Assignor/Tenant's interest in the Lease was assigned to Assignee/Tenant effective the 24 day of September, 2015 (the "Assignment").
- 4. Amendment. Pursuant to the Instrument, the Lease was amended, effective the 24 day of September, 2015 and as between Assignee/Tenant and Landlord, to allow for early termination of the Lease by Assignee/Tenant should its permission to operate healthcare services in Skagit County Public Hospital District No. 304 ("PHD 304") be terminated pursuant to the Restated Interlocal Agreement dated June 26, 2015 between Assignee/Tenant and PHD 304 (the "Amendment").
- 5. Consent. By the Instrument, the Landlord consented to both the Assignment and the Amendment.
- 6. Purpose of Memorandum of Lease. This Memorandum of Lease has been prepared for the purpose of recordation and notice, and it in no way modifies the provisions of the Lease.
