thence North 1 06'30" West, along the West line thereof, a distance of 328.55 feet;

thence Easterly along a non-tangent curve concave to the South whose radius point bears South 3°18'10" East, a distance of 738'39 feet, having a delta of 11°39'16", an arc distance of 150.19 feet;

thence South 81,38'54" East, a distance of 74.38 feet to the East line of Lot 56;

thence South 1°06'30" East, along said line, a distance of 60.83 feet to the true point of beginning of said line; thence North 81°38'54" West, a distance of 84.37 feet;

thence on a curve to the left having a radius of 678.39 feet, through a delta of 11°50'55", an arc distance of 140.29 feet to the West line of said Lot 56 and the end of said line.
