## LOAN MODIFICATION AGREEMENT

(PROVIDING FOR FIXED INTEREST RATE/CAPITALIZATION)

This Loan Modification Agreement ("Agreement"), made July 12, 2013, between BRYAN W HARRISON, ("Borrower") residing a 200 GARDNER RD, BURLINGTON, WA 98233-2145, and CitiMortgage, Inc. ("Lender") If Applicable, follow with successor by reason of merger with N/A and amends and supplements (1) the Mortgage, Deed of Trust, or Deed to Secure Debt (the "Security Instrument") dated 09/25/08 and recorded on 09/26/08, Document number 200809260093, Book number na, Page na in the Official Records of SKAGIT County, Washington and (2) the Note bearing the same date as, and secured by the Security Instrument , which covers the real and personal property described in the Security Instrument and defined therein as the "Property", located at 200 GARDNER ROAD, BURLINGTON WA, 98233-2145 the real property described as APN: 3867-000-036-0707 being set forth as follows:

In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

- 1. As of 07/12/13, the amount payable under the Note and Security Instrument (the "Unpaid Principal Balance") is U.S. \$ 261,409.18. The Borrower acknowledges that interest has accrued but has not been paid and the Lender has incurred, paid or otherwise advanced taxes, insurance premium, and other expenses necessary to protect or enforce its interest in the Note and the Security Instrument, and that such interest, costs and expenses in the total amount of \$ 13,238.12, have been added to the indebtedness under the terms of the Note and Security Instrument and the loan re-amortized over 360 months. When payments resume on 09/01/13, the New Unpaid Principal Balance will be \$ 274,647.30.
- 2. The Borrower promises to pay the New Unpaid Principal Balance, plus Interest, to the order of Lender. Interest will be charged on the Unpaid Principal Balance at the yearly rate of 4.000 % effective 08/01/13 (the "Interest Change Date").
