QUIT CLAIM & RELEASE OF TEMPORARY EASEMENT

WHEREAS, Skagit Land Trust, a Washington non-profit corporation (herein "SLT" or "Grantee") has purchased real property commonly identified as Skagit County Assessor Tax Parcel Numbers: P39088, P40135, and P40116 (herein the "Property"); and

WHEREAS, the Property is subject to a Temporary Easement and Waiver of Damages, dated August 13, 1976, and recorded under Skagit County Auditor's File No. 840838 (herein the "Temporary Easement") in favor of Skagit County, a Washington municipal corporation (herein "County" or "Grantor"); and

WHEREAS, while the Temporary Easement may have already expired by its own terms, SLT has requested that the County relinquish and/or terminate the Temporary Easement for the Property; and

WHEREAS, the terms of the Temporary Easement provide that the County is not responsible or liable for any improvements placed upon the Property pursuant to the terms of the Temporary Easement, and the County and SLT agree that the County shall continue to not be liable or responsible for any such improvements at or upon the Property, and

WHEREAS. County Public Works Department staff have determined that the County does not currently use Temporary Easement (and has not used the Temporary Easement for many years), and has also determined that the County has no planned or practical future use for the Temporary Easement, and County Public Works Department staff recommends that the County relinquish and/or terminate the Temporary Easement.

NOW THEREFORE, in consideration of the forgoing, the County and SLT agree as follows:

- 1. Quit Claim and Release of Temporary Easement: Subject to the terms herein, the Grantor, Skagit County, a political subdivision of the State of Washington (herein "County" or "Grantor"), for no monetary consideration and to clear title only, hereby releases, waives, relinquishes, assigns, conveys, and quit claims to the Skagit Land Trust, a Washington non-profit corporation (herein "SLT" or "Grantee"), the County's right, title and interest in that certain Temporary Easement and Waiver of Damages (herein the "Temporary Easement"), dated August 13, 1976, and recorded under Skagit County Auditor's File No.: 840838. A copy of the Temporary Easement is attached hereto as Exhibit "A", and is hereby incorporated by reference. This Quit Claim and Release of Temporary Easement shall only apply to the above-described Temporary Easement, and shall not apply to any other easements or properties owned by the County. This Quit Claim and Release of Temporary Easement shall become effective upon recording.
- 1.1 The County and SLT mutually agree that the County quit claims the County's right, title and interest in the Temporary Easement to SLT "as is" (without any representations or warranties of any kind, express or implied), and that the County makes no commitment as to the location, nature of, date of, or extent of flood control improvements (herein "improvements") made or placed at or upon the area of the Temporary Easement on the Property (if any). The County and SLT mutually agree that the County is not and shall not be responsible or liable for the use, operation, maintenance, and/or repair of any such improvements or upon the area of the Temporary Easement on the Property.
