MODIFICATION TO PROMISSORY NOTE AND DEED OF TRUST

This Modification to Promissory Note and Deed of Trust, (the "Modification") is made and entered into and effective this 28th day of November 2016, by and between Kathleen L. Recitals

- 1. (the "Deed of Trust")
- 2. Said Promissory Note was paid down by \$20,000, and resulting in a new outstanding balance of \$215,000.
- 3. By Modification dated October 2015, said the due date on said Note was extended until November 1, 2016.
- 4. Grantor and Beneficiary desire to modify the Promissory Note and Deed of Trust to extend the date upon which the entire balance is due and payable from "November 1, 2016" to "November 1, 2017".
- 5. As consideration for the above extension, the Grantor agrees to pay the following:
 - --The Grantor shall pay a loan extension fee to Kathy L. Larsson in the amount of \$4,790.00, which shall be added to the principle balance of the Note and amortized therewith
 - --The Grantor shall pay a Broker's Fee and admin fee to Investor's Choice Capital in the total amount of \$17,500, which total amount shall be added to the principle balance of the Note and amortized therewith.
 - -The Grantor shall pay document drafting fees to John McCrady, Attorney at Law, in the amount of \$500.00, which shall be added to the principle balance of the loan and amortized therewith.
 - -The Grantor shall pay title and escrow/courier fees in the amounts of \$687.89 and \$583.00 // respectively, which amounts shall be added to the principle balance of the Note and amortized therewith.

Now therefore, for and in receipt of the above considerations, the parties hereto agree as follows:

The Promissory Note and Deed of Trust shall be modified in part as follows:

- 1) The entire balance of this Note together with all interest and late fees, if applicable, shall be due and payable in full on the 1st day of November, 2017
- 2) The principle balance on the Promissory Note is hereby increased to \$239,060.89 and the Deed of Trust is modified to secure the Promissory Note as modified herein.
