Treasurer By hum Deputy note immediately to the left of Lot 2 of said Short Plat, that note reading, "Easement to Lot 2 for Installation, Operation & Maintenance of Sewage Disposal System," with an arrow from such note pointing to an area to the southwesterly side of Lot 2, and Grantors hereby convey to Grantee, and Grantee accepts an amended location for such easement, that being an easement for Installation, Operation and Maintenance of a Sewage Disposal System for the benefit of said Lot 2, that lot 2 being Skagit County parcel P130496, and the easement being over, across and through Lot 3, Short Plat #PL10-0206 as recorded under AF#201101120057, records of Skagit County, Washington, and being a portion of the southeast quarter of the southeast quarter of Section 4, Township 34 North, Range 2 East, W.M., the amended location being described as:

Beginning at the northwest corner of Lot 2 of said Short Plat; thence S 64°52′42″W, a distance of 161.39 feet; thence S 47°24′52″W, a distance of 130.00 feet; thence S 42°35′08″E, a distance of 30.00 feet; thence N 47°24′52″E, a distance of 115.00 feet; thence N 16°01′13″W, a distance of 13.29 feet; thence N 64°52′42″E, a distance of 148.01 feet to a point on the west line of said Lot 2; thence N 14°32′57″E, a distance of 25.98 feet to the point of beginning.

The amended easement described above is approximately as shown on the attached sketch, and is subject to and conditioned upon the following terms and conditions:

- 1. Grantee or Grantee's successors shall wholly bear the cost of any installation, maintenance and repair for the sewage disposal system.
- 2. Grantee or Grantee's successors shall maintain the sewage disposal system in good condition, so as to avoid the leakage, blockage or discharge of any sewerage within the easement area or onto Grantors' adjacent property.
- 3. Grantee or Grantee's successors shall provide all proper safeguards and shall assume all risk in the performance of activities under this easement.
