I, Will Reichardt, Sheriff of Skagit County, State of Washington, do hereby certify that an AMENDED ORDER OF SALE did issue out of the Superior Court of SKAGIT County, Washington, on May 4, 2016, upon a judgment rendered in Superior Court of SKAGIT County, Washington on January 19, 2016, in favor of EQUITY TRUST COMPANY, CUSTODIAN FOR THE BENEFIT OF MARTIN W. SAVINSKY IRA, for the sum of four hundred seven thousand, seven dollars, and five cents (\$407,007.05).

The AMENDED ORDER OF SALE, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on May 10, 2016, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the AMENDED ORDER OF SALE.
