## RECITALS:

- 1. This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust dated 5/20/2010, recorded in Auditor's/Recorder's No. 201005200119, rerecorded under Auditor's/Recorder's No. 201702060124, records of SKAGIT County, Washington, from FAYE MATIER, A SINGLE PERSON, AS HER SEPARATE ESTATE, as Grantor, to UNITED STATES OF AMERICA ACTING THROUGH THE STATE DIRECTOR, USDA RURAL DEVELOPMENT, RURAL HOUSING SERVICE FOR THE STATE OF WASHINGTON,, as Trustee, in favor of UNITED STATES OF AMERICA ACTING THROUGH THE RURAL HOUSING SERVICE OR SUCCESSOR AGENCY, UNITED STATES DEPARTMENT OF AGRICULTURE, as Beneficiary.
- 2. Said Deed of Trust was executed to secure, together with other undertakings, the payment of a promissory note in the sum of 165000, with interest thereon, according to the terms thereof, in favor of UNITED STATES OF AMERICA ACTING THROUGH THE RURAL HOUSING SERVICE OR SUCCESSOR AGENCY, UNITED STATES DEPARTMENT OF AGRICULTURE and to secure any other sums of money which might become due and payable under the terms of said Deed of Trust.
- 3. The described Deed of Trust provides that the real property conveyed therein is not used principally for agricultural or farming purposes.
- 4. Default having occurred in the obligations secured and/or covenants of the Grantor as set forth in the "Notice of Trustee's Sale" described below, which by the terms of the Deed of Trust made operative the power to sell, the thirty-day advance "Notice of Default" was transmitted to the Granton or his successor in interest, and a copy of said Notice was posted or served in accordance with law.
