This Agreement is made this May 11, 2018, by and between U.S. Bank National Association ("Bank") and U.S. Bank National Association ("Refinancer").

Bank is the beneficiary under a deed of trust (the "Junior Deed of Trust") dated 01/05/2016, granted by STEVEN A BRICKLEY UNMARRIED ("Borrower"), and recorded in the office of the County Recorder, SKAGIT County, Washington, on Book , Page , as Document 201602160069, encumbering the real property described therein (collectively, the "Property").
