FOR VALUABLE consideration, none of which includes the payment of money by Grantee to Grantor receipt of which is hereby acknowledged, GRANTOR, STATE OF WASHINGTON, Department of Enterprise Services formerly known as the Department of General Administration, hereby conveys and quit claims to the GRANTEE, CITY OF SEDRO-WOOLLEY, a Municipal Corporation in Skagit County, Washington, the real property described on Exhibit A situated in Skagit County, Washington to wit:

SUBJECT TO the following covenants and exceptions:

As required by Section 6006, Chapter 35, Laws of 2016, 2016 First Special Session (ESHB 2380), neither Grantee nor its successors shall convey or otherwise transfer fee title to the Property to a non-governmental entity or a private person. This covenant shall run with the Property to all heirs, successors, and assigns of Grantor and Grantee. Should the Grantee convey or otherwise transfer fee title to the Property to a governmental entity, the real property transfer agreement between Grantee and that governmental entity shall include a substantially similar restrictive covenant. Any modification to this Covenant requires authorization by the Washington Legislature. Grantee and its heirs and assigns hereby waive any right to challenge or oppose the legal enforceability of this Covenant on such ground that existed at the time this Covenant was originally made;

If the Grantee has fully expended the Maintenance Payment funds provided by the Grantor for maintenance to the Cemetery, and if the Assignee subsequently desires to reconvey the Cemetery by quit claim deed to the State, it may do so if done within twenty-five years of full execution of this deed; provided that the State may refuse such reconveyance if, due to the City's acts, hazardous wastes or substances have been released during the City's ownership on the property, which release requires remedial action or cleanup under state or federal law, and such cleanup has not occurred and been fully completed.

References herein to Grantor and Grantee shall include each party's respective assigns and successors.

TO HAVE AND TO HOLD the same unto the said Grantee and, subject to the covenants herein stated, unto its successors and assigns forever, with all appurtenances thereunto belonging.

That portion of the West 25 rods of the Northwest quarter of the Southeast quarter of Section 8, Township 35 North, Range 5 East, W.M., described as follows:

Beginning at the Northeast corner of said West 25 rods; thence S 00°56'01" E along the East line of said West 25 rods, a distance of 624.11 feet to the point of beginning of this description; Thence continuing S 00°56'01" E along said East line, a distance of 426.00 feet to a point on the curve of the North line of Helmick Road from which the center of said curve bears N 30°36'53" W, a distance of 685.98 feet; thence Southwesterly along said curve through a central angle of 4°25'56" and an arch length of 53.07 feet to its point of tangency; thence continuing along the North line of Helmick Road S 63°49'03" W, a distance of 87.01 feet; thence N 30°06'24" W, a distance of 292.88 feet; thence N 48°15'33" E, a distance of 354.78 feet to the point of beginning of this description.
