The Notice was mailed to all persons entitled to notice thereof and posted in compliance with the requirements of RCW Ch. 61.24.

On August 2, 2017, Grantor filed a petition for relief under Chapter 13 with the U. S. Bankruptcy Court, Western District of Washington at Seattle, under case number 17-13429-MLB. As a result of the filing of such bankruptcy petition, the trustee's sale, as originally scheduled for September 8, 2017, was automatically stayed by Section 362 of the Bankruptcy Code. On January 4, 2018, by court order, said bankruptcy case was dismissed.

A trustee's sale of the real property pursuant to the Amended Notice of Trustee's Sale recorded January 26, 2018 as described above, was scheduled for March 2, 2018, which was subsequently continued to April 13, 2018, and subsequently continued to May 11, 2018, and subsequently continued to June 29, 2018.

On June 28, 2018, Grantor filed a petition for relief under Chapter 7 with the U. S. Bankruptcy Court, Western District of Washington at Seattle, under case number 18-12571-MLB. As a result of the filing of such bankruptcy petition, the trustee's sale,

as then scheduled for June 29, 2018, was automatically stayed by Section 362 of the Bankruptcy Code. On August 21, 2018, an Order granting Puget Sound Investors, LLC's Motion for Relief From Stay was entered by the Honorable Marc Barreca, U.S. Bankruptcy Judge, thereby lifting the bankruptcy stay as to the real property described above so as to allow the beneficiary to proceed with state law remedies under the parties' Promissory Note, Deed of Trust, and other loan documents.

NOTICE TO OCCUPANTS OR TENANTS
