Peoples Bank, A Washington Corporation referred to herein as "lender", is the owner and holder of a Deed of Trust dated 02/23/2021 ____, executed by Jeffrey F Rindal and Teresa T Rindal, husband and wife, which is recorded under auditor's file No. 202103010156 ___ records of County, Washington (which is to be recorded concurrently herewith).
- 3. <u>Jeffrey F Rindal and Teresa T Rindal, husband and wife,</u> referred to herein as "owner", is the owner of all real property described in the mortgage identified above in paragraph 2.
- 4. In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its mortgage and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of his mortgage identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above, and all advances or charges made or occurring thereunder, including any extension or renewal thereof.
