# PERPETUAL AND EXCLUSIVE DRIVEWAY AND UTILITY EASEMENT

THIS PERPETUAL AND EXCLUSIVE DRIVEWAY AND UTILITY EASEMENT is made this date between MICHAEL G. JANSMA and DIANNE DEBOER, husband and wife ("JANSMAS") and LU JI, Trustee of FREEDOM QUEST TRUST (the "TRUST").

#### RECITALS

**A.** JANSMAS and the TRUST own adjacent property in Skagit County, Washington.

JANSMAS' property is legally described on Exhibit A.

The TRUST'S property is legally described on Exhibit B.

**B.** JANSMAS' are providing the TRUST with a driveway and utility easement over, under, across and through their property as legally described on Exhibit C.

## EASEMENT

JANSMAS and the TRUST agree as follows:

- 1. **GRANT OF EASEMENT**. JANSMAS grant, establish and convey an immediate, perpetual, exclusive easement to the TRUST on, across and under the JANSMAS property for access and utilities.
- 2. <u>EASEMENT RIGHTS.</u> The TRUST shall have the right to exclusive use of this easement for driveway, access and utilities. There are no restrictions on this use.
- 3. CONSTRUCTION AND MAINTENANCE. The driveway described in this easement shall be constructed and maintained by the TRUST at its sole cost and expense.
- 4. **PROOF OF TITLE.** JANSMAS represent that they have the right to transfer these easement rights to the TRUST.

- 5. EASEMENT TO RUN WITH LAND. This grant of easement shall run with the land and be binding on and shall endure to the benefit of the parties, their heirs, successors, personal representatives and assigns.
- **6. BINDING EFFECT.** This agreement shall be binding upon the parties, their successors, heirs, personal representatives and assigns.
