THIS AGREEMENT further saith naught.

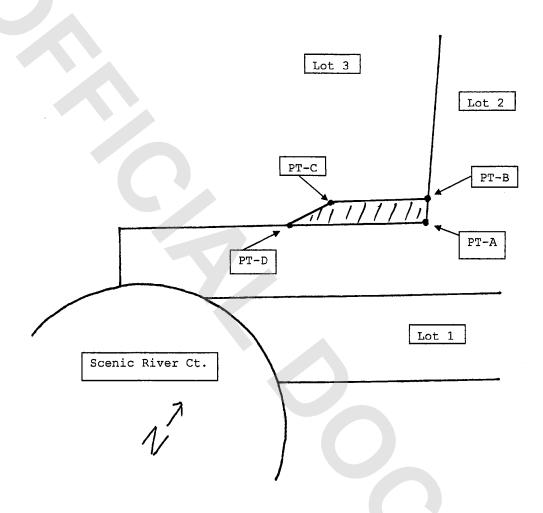
