SIGN PERMIT DEVELOPMENT AGREEMENT

This Sign Permit Development Agreement ("Agreement") is made and entered into this day of 27 fig. 2021, by and between The Starlight Group LLC, a Washington limited liability company ("Owner") and the City of Burlington, a Washington municipal corporation (the "City"). Owner and the City are each a Party and collectively the Parties to this Agreement.

For good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, including without limitation the representations, warranties, and promises set forth herein, Owner and the City hereby agree as follows:

- 1. <u>Property.</u> Owner is the owner of five individual lots within the boundaries of Binding Site Plan (BSP) 1-99 recorded under Skagit County Auditor's File Number 200005030015. The five individual lots comprising the owner's property are described as lots 1-5 of BSP 1-99 and are identified by Skagit County Auditor's Office as parcel numbers P116701, P116702, P116703, P116704, and P116705. The five individual lots comprising the owner's property are illustrated on attached Exhibit "A". BSP BULL 1-99
- 2. <u>Development</u>. Owner has applied to and received from the City permission to install a Development Complex Sign on the Property in order to establish a single consolidated freestanding sign ("Sign") for the owner's property. The Development Complex Sign authorized by the City is an "Electronic Message Center Sign as defined by the Burlington Municipal Code.
- 3. <u>Future Sign Restrictions.</u> In accordance with the Burlington Municipal Code the owner's property is considered a Development Complex and only one freestanding sign is permitted within the boundaries of the Development Complex. In order to ensure compliance with these limitations and restrictions the owner agrees not to install any freestanding signs on the owner's property except for the single development complex sign authorized by the City. The owner also agrees to remove any existing freestanding signs located on the owner's property.
- 4. <u>Limitations of Agreement.</u> This agreement shall not be construed to limit the City's ability to adopt future sign code provisions or development regulations which may affect the owner's property or the sign authorized by the City. The owner shall fully comply with all existing and future Burlington Municipal Code requirements.
- 5. <u>Binding Effect</u>. This Agreement shall be binding upon and inure to the benefit of the Parties and their successors, heirs, assigns, and personal representatives.
- 6. <u>Applicable Law.</u> This Agreement shall be governed by and construed in accordance with the laws of the State of Washington. Jurisdiction over and venue of any suit arising out of or related to this Agreement shall be exclusively in the state and federal courts of Skagit County, Washington.
- 7. <u>Entire Agreement / Parties</u>. This Agreement contains the entire agreement between the Parties with respect to this matter. It may not be modified except in a writing signed by the Parties. This is Agreement is not intended to, nor shall it be construed to, benefit any person or entity except the Parties and shall not be enforced by or construed to give rights to any third-party.
- 8. <u>Waiver</u>. The waiver by a Party of a breach of any provision of this Agreement by the other Party shall not operate or be construed as a waiver of any subsequent breach by that Party. No waiver shall be valid unless in writing and signed by the Party against whom enforcement of the waiver is sought.

- 9. <u>Recording</u>. Prior to installing the sign authorized by the City this Agreement shall be recorded with the Skagit County Auditor's office.
- 10. <u>Authority</u>. Owner represents and warrants that it is duly organized, validly existing and in good standing in the State of Washington. Owner further represents and warrants that the person or persons executing this Agreement on Owner's behalf have the requisite authority to bind Owner.
