- 1. This Affidavit provides information for the record regarding that certain Community Property Agreement dated April 23, 2021, and executed by STEVEN K. UFER and VALERIE J. UFER, husband and wife (the "Agreement"). The Agreement was recorded in the Office of the County Auditor in Skagit County, Washington, on September 14, 2021, under File No. 202109140052. The statements set forth in this Affidavit are representations of fact that maybe relied upon by all parties dealing with any property, whether real or personal, belonging to the above-named parties, including but not limited to that certain real estate located in Skagit County, Washington, and more fully described on Exhibit "A" attached and made a part hereof.
- 2. STEVEN K. UFER (the "Decedent") was one of the parties to the Agreement and died on August 26, 2021, in Mount Vernon, Skagit County, Washington.
- 3. The parties to the Agreement were legally competent at the time of the Agreement and executed no subsequent Wills or agreements that would have the effect of abrogating or nullifying the Agreement. The Agreement was validly executed and in full force and effect at the time of the Decedent's death.
