## PROTECTED CRITICAL AREA EASEMENT (PCAE)


In consideration of Skagit County Code (SCC) 14.24.090, requirements for recording of protected critical area easement (PCAE), for areas included under Revised Short CaRD No. PL-19-0375, and mutual benefits herein Geoff DeVries, a married man, Suzanne L. DeVries, spouse, George P. DeVries and Nancy S. DeVries, Trustees of the DeVries Family Trust dated 02/25/02, the owners in fee of that certain real property described on said Short Plat, does hereby grant, convey and warrant to Skagit County, a political subdivision of the State of Washington, a non-exclusive perpetual easement establishing a PCAE over, along and across those portion of the project, denoted as Open Space Protected Areas Lot 1 (OS-PA) for Protected Critical Area Easement PCAE within portions of said Revised Short CaRD No. PL-19-0375 described below, together with the right of ingress and egress to and from the easements for the purpose of monitoring and enforcing property operation and maintenance of the PCA described herein.


The easement is granted subject to and conditioned upon the following terms, conditions and covenants:

1. The PCAE legal description is as follows Open Space Protected Areas Lot 1 (OS-PA) for Protected Critical Areas, as shown on the face of said Revised Skagit County Short CaRD No. PL-19-0375, recorded under Skagit County Auditor's File No. 202111240052, records of Skagit County, Washington, being in portions of the SE 1/4 of the NE 1/4 of Section 2, Township 35 North, Range 4 East, W.M. (Note: This PCAE supersedes the previous one recorded under Skagit County Auditor's File No. 20207130115)
2. Grantor shall hereafter be responsible for maintaining and repairing PCAE areas as described herein and is hereby required to leave PCAE areas undisturbed in a natural state, "With the exception of activities identified as Allowed Without Standard review under SCC 14.24.070, any land-use activity that can impair the functions and values of critical areas or their buffers through a development activity or the disturbance of the soil or water, and/or removal of, or damage to, existing vegetation shall require critical areas review and written authorization pursuant to SCC 14.24" (SCC 14.24.060). No clearing, grading, filling, logging or removal of woody material, building, construction or road construction of any kind, planting of non-native vegetation or grazing of livestock is allowed within the PCAE areas except as specifically permitted by Skagit County on a case-by-case basis consistent with SCC 14.24.
3. Grantor retains the right to use and possession of the real property over which the easement is granted to the extent permitted by Skagit County as low impact uses and activities which are consistent with the purpose and function of the PCAE and do not detract from its integrity may be permitted with the PCAE depending on the sensitivity of the habitat involved. Examples of uses and activities which may be permitted in appropriate cases, with prior County written approval separate from this agreement, include pedestrian trails, viewing platforms, stormwater management facilities and utility easements. Provided further that the grantor agrees not to interfere with, obstruct or endanger Skagit County's use of the easement.
4. Should any human disturbance of the PCAE occur, the fee owners shall have the obligation to restore and return the affected area to its natural state immediately, under the provisions of a County approved mitigation plan.
5. The parties recognize that this easement is created, granted and accepted for the benefit of the inherent natural functions provided by the PCAE, but shall not be construed to provide open or common space for owners within the project or members of the public. By acceptance of the easement for the purposes described, Skagit County does not accept or assume any liability of acts or omissions of the fee owners, his or her invitees, licensees or other third parties within the easement area. Grantor(s) hold Skagit County harmless from any damage or injury to any property or person by any person entering the easement area not expressly authorized to do so by Skagit County.

- 6. Grantor(s) agrees that this easement shall run with the land and that the rights and obligations of Grantor(s) and Skagit County shall inure to the benefit of each and shall be binding upon their respective heirs, successors and assigns.
- 7. Grantor(s) covenants that they own the property legally described herein and has lawful right to convey the interest in the property to Skagit County for the benefit of the public forever.
