The GRANTOR, North Star Trustee, LLC, as present Trustee under that Deed of Trust, as hereinafter particularly described, in consideration of the premises and payment recited below, hereby grants and conveys, without warranty, to: Brook Real Estate LLC and Eastside Funding, LLC for Security Purposes only, GRANTEE, that real property, situated in the County of Skagit, State of Washington, described as follows:

1. This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust between PEGGY A. GRIFFIE, A SINGLE PERSON, as Grantor, to FIRST AMERICAN TITLE INSURANCE CO., as Trustee, and WELLS FARGO FINANCIAL WASHINGTON 1, INC., as Beneficiary, dated 6/16/2008, recorded 6/30/2008, as Instrument No. 200806300124, The subject Deed of Trust was modified by Loan Modification Agreement dated 7/24/2018. records of Skagit County, Washington.
2. Said Deed of Trust was executed to secure, together with other undertakings, the payment of one promissory note in the sum of \$151,874.78 with interest thereon, according to the terms thereof, in favor of WELLS FARGO FINANCIAL WASHINGTON 1, INC. and to secure any other sums of money which might become due and payable under the terms of said Deed of Trust.
3. The described Deed of Trust provides that the real property conveyed therein is not used principally for agricultural or farming purposes.
4. Default having occurred in the obligations secured and/or covenants of the Grantor, as set forth in Notice of Trustee's Sale described below, which by the terms of the Deed of Trust make operative the power to sell, the thirty-day advance Notice of Default was transmitted to the Grantor, or his successor in interest, and a copy of said Notice was posted or served in accordance with law.

Rushmore Loan Management Services, LLC as servicer for and on behalf of U.S. Bank National Association, not in its individual capacity but solely as trustee for the RMAC Trust, Series 2016-CTT, being then the holder of the indebtedness secured by said Deed of Trust, delivered to said Trustee a written request directing said Trustee or his authorized agent to sell the described property in accordance with law and the terms of said Deed of Trust.

The Trustee, in its aforesaid "Notice of Trustee's Sale," fixed the place of sale as, main entrance Skagit County Courthouse, located at 3rd & Kincaid, Mount Vernon, WA, a public place, on 4/8/2022 at 10:00 AM, and in accordance with law caused copies of the statutory "Notice of Trustee's Sale" to be transmitted by mail to all persons entitled thereto and either posted or served prior to 90 days before the sale; further, the Trustee caused a copy of said "Notice of Trustee's Sale" to be published once between the thirty-fifth and twenty-eighth day before the date of sale, and once between the fourteenth and seventh day before the date of sale in a legal newspaper in each county in which the property or any part thereof is situated: and further, included in this Notice, which was transmitted to or served upon the Grantor or his successor in interest, a "Notice of Foreclosure" in substantially the statutory form.
8. During foreclosure no action was pending on an obligation secured by said Deed of Trust.


