## **EXHIBIT "A"**

## LEGAL DESCRIPTION

PARCEL "A":

That portion of the Southwest 1/4 of the Northeast 1/4 of Section 11, Township 35 North, Range 7 East, W.M., lying Northerly of the County road (formerly State Highway 17-A), as the same was originally conveyed to Skagit County by deed dated October 4, 1927, and recorded February 2, 1928, in Volume 146 of Deeds, page 313, under Auditor's File No. 210336, records of Skagit County, Washington;

EXCEPT that portion lying within the as built and existing County road along the West line of said subdivision;

ALSO EXCEPT the following described tract:

Beginning at the Northwest corner of said Southwest 1/4 of the Northeast 1/4;

thence East along the North line of said Southwest 1/4 of the Northeast 1/4, a distance of 520 feet to the Northeast corner of that certain tract conveyed to Colin R. Thomson and Zoel M. Thomson, husband and wife, by deed dated May 8, 1953, and recorded May 11, 1953, under Auditor's File No. 488120, records of Skagit County, Washington; thence Southerly along the Easterly line of said Thomson Tract a distance of 570 feet to the Southeast corner of that certain tract conveyed to L.G. Cunningham and Ardath G. Cunningham, husband and wife, by deed dated May 4, 1966, and recorded May 6, 1966, under Auditor's File No. 682486, records of Skagit County, Washington, and the true point of beginning of this description;

thence Westerly along the Southerly line of said Cunningham Tract to a point on the West line of said subdivision that is 610 feet South of the Northwest corner of said Southwest 1/4 of the Northeast 1/4; thence South along the West line of said subdivision to the North line of the above referred to County road; thence Northeasterly along said road a distance of 620 feet to the Southeast corner of said Thomson Tract; thence Northwesterly along the East line of said Thomson Tract to the true point of beginning.
