THIS GRANT OF EASEMENT is made this 4th day of 0 (1) but 2022, by and between Fisher Lot 1-B LLC, a Washington limited liability company, Grantor, and Logan Engle & Cady Paynton Engle, husband and wife, Grantees.

For and in consideration of an agreement between the parties, and for other good and valuable consideration in hand paid, Grantor conveys to Grantees a non-exclusive easement for a sanitary sewer line and associated appurtenances, and the maintenance thereof, over, under and through the following-described real property, located in Skagit County Washington:

EXCEPT THE WEST 150 FEET OF THE SAID LOT 2.

The parties further covenant and agree, on behalf of themselves and their respective successors and assigns, as follows:

- 1. In the event that Grantees subdivide the property described above, the subject easement shall equally benefit the subdivided parcels thereof.
- 2. All maintenance, repairs and/or replacement of the subject sewer line located on Grantees' property shall be at Grantees' sole cost and expense.
- 3. The parties shall share equally in any maintenance, repairs and/or replacement of the portion of the sewer line located on Grantor's property (of which the subject sewer line easement is a continuation), provided that if either party subdivides its property, that the costs of maintenance, repairs and/or replacement of the portion of the said sewer line lying on Grantor's property shall be divided equally among all of the parcels connected to the same.
