## LEASE ASSIGNMENT AND ASSUMPTION AGREEMENT

This LEASE ASSIGNMENT AND ASSUMPTION AGREEMENT (this "Agreement") is made and entered into as of March 21, 2024 (the "Effective Date"), by and between HORIZON TOWER LIMITED, LLC, a Kansas limited liability company ("Assignor"), and WEST COAST TOWER HOLDINGS, LLC, a Delaware limited liability company ("Assignee").

WHEREAS, Assignor desires to assign the Lease to Assignee, and Assignee desires to accept such assignment and assume all of Assignor's obligations under the Lease, all on the terms and conditions set forth in this Agreement.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the undersigned hereby agree as follows:

- Assignment and Assumption. Assignor hereby assigns, transfers and conveys to Assignee 1. any and all of its right, title and interest in, to and under the Lease, effective from and after the Effective Date, and Assignee hereby accepts the foregoing assignment of the Lease as of the Effective Date and hereby assumes and agrees to discharge and perform, in accordance with the terms thereof, all of the obligations of the "tenant" under the Lease, to the extent the same arise on or after the Effective Date.
- Further Instruments. Assignor and Assignee each hereby agrees that, if requested by the other party, it shall do, execute, acknowledge and deliver, at the requesting party's expense, all acts, agreements, instruments, notices and assurances as may be reasonably requested by the other party to further effect and evidence the transactions contemplated hereby.
- Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the state in which the Premises is located, without regard to the conflict of law principles thereof.
