c) *11:00 a.m. Pledge of Allegiance

Chair Janicki reconvened the proceedings at 11:00 a.m. and led the gallery in the salute to the flag.

d) *11:00 a.m. - 12:00 p.m. Planning and Development Services – Jack Moore, Director:

Planning and Development Services Director Jack Moore introduced Senior Planner Robby Eckroth to provide a presentation on the Critical Areas Ordinance update.

1. Public Hearing: To Consider Testimony on the Critical Areas Ordinance Update

Senior Planner Robby Eckroth provided a brief presentation regarding the Critical Areas Ordinance (CAO) update. The Washington State Growth Management Act (GMA) required counties to update their Comprehensive Plans and implement development regulations every ten years to maintain consistency with state development codes and to plan for the next 20 years. Part of the Comprehensive Plan update included revising, if needed, the Critical Areas Ordinance. A work session had been held on July 7, 2025 with the Board where they reviewed the proposed Amendments to the Critical Areas Ordinance.

Mr. Eckroth said the Commissioners were currently scheduled to take possible action on the CAO update on August 4, 2025 and public comments would be accepted until 4:30 p.m. July 28, 2025.

Chair Janicki opened the public hearing.

Skagit Land Trust Board President Kirk Johnson reviewed comments and recommendations from Skagit Land Trust to the Critical Areas Ordinance and he reviewed the recommendation to create a Climate/Environment Advisory Board. Mr. Johnson also submitted Skagit Land Trust's comments in writing.

Friends of Skagit County President Randy Good provided comments regarding Skagit County's Agricultural Critical Areas Ordinance, using best available science to make decisions, and discussed results of the water quality monitoring programs and additional field work performed over two years by the Cattlemen's Association that showed buffers did not help decrease stream temperatures/conditions on the ground.

Rick Haley, on the Board of Directors for Skagit Fisheries Enhancement Group (SFEG), provided comments about their work to restore salmon populations through habitat restoration. They requested changes to 14.24.070 to remove and/or update Section C regarding notifying the Planning Director of certain tasks and activities. Activities listed were not impactful, while other activities outlined seemed more pertinent for Director review but were not included (as they would be disturbing the soils for utility work and maintenance of drainage systems).

Executive Director of Skagitonians to Preserve Farmland Lora Claus discussed concerns regarding the proposed increase to the width of riparian buffers on streams which would remove farmland currently in use for food production. She said many questions needed to be answered and blanket regulations were not a good policy. She discussed the meaningful work being accomplished through the Voluntary Stewardship Program.

Rebecca Peck of Bow provided comments about protecting vital areas and protecting farmland. With the climate crisis escalating, she suggested protections beyond the state's minimum requirements to ensure the protection of the environment and of water quality.

Tammie Grobschmit of Big Lake said that she had been a member of the Lake Management Noxious Weed Advisory Committee managed by staff in Public Works since 2001 and she reported that residents in Big Lake had been seeing more impactful pollution in the lake over the years with continued development and growth. She asked that the 200 foot consideration be expanded to ensure the entire watershed was included.

Jan Edelstein of Big Lake discussed the importance of expanding the 200 foot limit for new development and shared that the best available science supported additional protections beyond only using the state's stormwater manual and that new development needed a report analyzing the flow of water from the site to the receiving water source and up to one mile. In addition, CAO procedures for public participation violated the GMA requirement for public notice and participation.

Kristine Johnson of Big Lake shared that in the 45 years since she's lived there, the lake had gotten more polluted.

Jake Koopmans of Seattle and present for his parents who live in Big Lake discussed concerns with a development project near Big Lake and the importance of implementing stormwater management reviews, precautions, and said that Impact Assessments needed to be done for new development.

Melissa Bishop of Sedro-Woolley provided comments about the new development project in Big Lake

for 105 new homes and discussed the importance of applying the same stormwater regulations to the existing 800 - 1,000 homes that had already been built surrounding Big Lake to ensure meaningful improvements were made to the health of the lake.

Heather Spore, representing the Swinomish Indian Tribal Community, discussed concerns regarding the timing of the CAO update, insufficient time between comment periods, the lack of responses to some of Tribe's substantive questions and concerns, and the denial to provide additional time for document review after they requested an extension. She informed the Commissioners that the Tribal Senate requested mediation through the Department of Commerce so that the Tribe and county could resolve and coordinate efforts to ensure CAO satisfied important requirements.

Land and Water Policy Manager for Resources Kaia Hayes, an environmental non-profit in Whatcom and Skagit Counties, discussed their support for riparian buffers and a no net loss approach to mitigating impacts to critical areas. They supported comments submitted by the Swinomish Indian Tribal Community and Evergreen Islands and asked that their feedback be integrated. Concerns were discussed about climate impacts and response to the challenges of sea level rise, fires, etc. for regional resilience.

Friends of Skagit County member Ellen Bynum provided comments about past work through the GMA for critical areas and other lands for development regulations. GMA stated that critical areas sometimes needed protection on a larger scale by multiple entities and an RCW outlined special considerations for critical areas that had anadromous fisheries which included Big Lake. Friends of Skagit County also asked that procedures for public participation be improved.

Kyle Loring, representing Evergreen Islands, expressed support for the comments heard from the Swinomish Indian Tribal Community. Evergreen Islands appreciated some of the changes made to the CAO and he reviewed additional recommended changes regarding wetlands, buffers, and riparian management zones. They also asked that the allowance of certain development activities in critical areas, like docks and bulkheads, be stricken and be consistent with the Shoreline Master Program.

Rob Eleveld of Big Lake provided comments about impacts that existed beyond 200 feet for new development to take into account and the county should consider the mile measurement outlined by the state when a critical area was involved. He also asked that public notice be written into the code and improved.

Board President of Evergreen Islands Marlene Finley provided comments about additional changes to adopt or decline and she added that reducing the risk of wildland fires, providing evacuation routes, and ensuring vegetation was managed in buffers for fire protection be included.

Chair Janicki thanked everyone for their comments. Further discussion would be held with staff regarding the request the Swinomish Indian Tribal Community shared that they made to the Department of Commerce for additional review time and the decision on the CAO update would be held on August 4, 2025 or later depending on the outcome of the Tribe's request.

Chair Janicki recessed the proceedings at 11:54 a.m.

- Resolution to submit the updated Housing and Urban Development (HUD) Assurances and Certificates application for FY2025 HOME Investment Partnerships Annual Action Plan as previously approved in Resolution No. R20250127 and to designate Chair Lisa Janicki as the authorized representative to sign the Agreement. (Resolution No. R20250167)
- 3. Personal Services Agreement with Community Action of Skagit County to provide short-term rental assistance as well as Housing and Essential Needs for households that are homeless and at imminent risk of homelessness through the Targeted Prevention model. Compensation shall not exceed \$829,376. The Agreement is ratified to commence on July 1, 2025 and continue until June 30, 2026. (Contract No. C20250366)
- 4. Personal Services Agreement with Chinook Enterprises to provide Individualized Employment, Group Supported Employment, and Community Inclusion services to eligible individuals with developmental disabilities.
