4. Amendment No. 2 to Personal Services Agreement No. C20240359 with Housing Authority of Skagit County to provide strategic planning activities/services. This Amendment extends the term of the Agreement from December 31, 2024 to March 31, 2025, establishes a GL expenditure code for the Agreement, and amends Scope of Work, Deliverables #2. Compensation remains the same and shall not exceed \$50,000. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

c) ASSIGNED COUNSEL:

5. Personal Services Agreement with Legal Counsel for Youth and Children to provide indigent defense representation for cases referred from Superior Court, Juvenile Court, and District Court. Compensation is based on a rate schedule and shall not exceed \$300,000. The Agreement is ratified to commence on January 1, 2025 and shall continue until December 31, 2026.

- 6. Agreement with Economic Development Alliance of Skagit County (EDASC) to award \$47,000 for marketing and administrative services for Skagit County. The Agreement is ratified to commence on January 1, 2025 and continue until December 31, 2025.
- 7. Funding Agreement with Skagitonians to Preserve Farmland to award \$10,000 of Lodging Tax funds to support marketing and advertising as authorized by Resolution No. R20240220. The Agreement is ratified to commence on January 1, 2025 and continue until December 31, 2025.

e) EMERGENCY MEDICAL SERVICES:

- 8. Funding Agreement with the City of Anacortes to contribute to the applicant contribution portion of the grant award for the purchase of an EMS patient transport capable boat for use by the City of Anacortes Fire Department in response to EMS incidents. The County will compensate the City a maximum of \$75,000 towards the applicant portion of the FEMA Port Security Grant Award. The Agreement shall commence on the date of execution and continue until December 31, 2030.
- 9. Amendment No. 2 to Personal Services Agreement No. C20180327 with Aero Skagit Emergency Services to provide Basic Life Support (BLS) Ongoing Training and Evaluation Program (OTEP) training in the "Aero Skagit Training Hub" that includes training Fire Districts 10, 19, 24, Concrete Fire District and Newhalem Fire Brigade a minimum of two times per site, per year for 2018 through 2024. This Amendment extends the term from December 31, 2024 to June 30, 2025. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
- 10. Amendment No. 2 to Interlocal Cooperative Agreement No. C20180418 with City of Sedro-Woolley Fire Department for the provision of Basic Life Support (BLS) Ongoing Training and Evaluation Program (OTEP) training in the "Sedro-Woolley Fire Department Training Hub" that includes training Fire Districts 4, 8, 16, Town of Hamilton and Clear Lake a minimum of 12 times per year for 2018 through 2024. This Amendment extends the term from December 31, 2024 to June 30, 2025. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

11. Resolution awarding the bid for two (2) security x-ray imaging systems to Autoclear LLC in the amount of \$21,675.

Compensation to Skagit County shall not exceed \$5,000 per year plus tax for the flights, and \$144 per year for three Pictometry Connect Explorer licenses which may change in 2026 depending on the agency's needs. Total compensation to Skagit County is estimated at an amount not to exceed \$11,168 including applicable sales tax. The Agreement shall commence on the date of execution and continue for two (2) years.

Total compensation to Skagit County is estimated at an amount not to exceed \$11,072 including applicable sales tax. The Agreement shall commence on the date of execution and continue for two (2) years.

i) PUBLIC DEFENDER:

15. Amendment No. 1 to Personal Services Agreement No. C20230590 with Gregory Dixon, Attorney at Law, to provide legal defense services to persons detained under the Involuntary Treatment Act. This Amendment extends the term from December 31, 2024 to February 28, 2025. Compensation remains the same and shall not exceed \$86,400. All other terms and conditions of the original Agreement shall remain in effect.

j) PUBLIC HEALTH:

- 16. Resolution authorizing Chair Lisa Janicki to electronically sign the submission of Interagency Agreement for Reentry Demonstration Initiative Project with Washington State Health Care Authority (HCA) Contract Number K8163 to provide pre-release services for individuals while in or preparing for release from a carceral facility (i.e., state prison, county/city jail, or correction facility).

- 18. Interlocal Cooperative Agreement with the City of Mount Vernon to facilitate a senior services program at the Mount Vernon Senior Center. Compensation to Skagit County shall not exceed \$65,080. The Agreement is ratified to commence on January 1, 2025 and continue until December 31, 2025.

k) PUBLIC WORKS:

- 19. Memorandum of Understanding (MOU) for the Land Transfer Navigators Program Supporting Transfer and Access on Agricultural Lands between American Farmland Trust, a District of Columbia nonprofit corporation (AFT) and Skagit County Farmland Legacy Program (Navigator). This MOU clarifies the framework of expectation for grants to be received by Skagit County Farmland Legacy Program from American Farmland Trust, for training and work supporting the transfer of agricultural land to a new generation of growers in Skagit County. Compensation to Skagit County shall not exceed \$100,000. The Agreement is ratified to commence on October 1, 2024 and continue until September 30, 2027.
- 20. Interlocal Cooperative Agreement with Skagit Conservation District to coordinate the development and implementation of a stormwater education and outreach program in Skagit County to continue to meet requirements of the National Pollutant Discharge Elimination System (NPDES) Western Washington Phase II Municipal Stormwater Permit. Compensation is based on a fee schedule and shall not exceed \$32,584. The Agreement is ratified to commence on January 1, 2025 and shall continue until December 31, 2026.
- 21. Personal Services Agreement with Northwest Center Services, dba Lithtex NW to provide bulk mailing services for projects and programs, such as the Clean Samish Initiative, Lake Management District newsletters, public meeting invitations, and landowner outreach correspondence. Compensation is based on a fee schedule and shall not exceed \$20,000. The Agreement shall commence on the date of mutual execution and continue until December 31, 2026.
- 22. Amendment No. 3 to Personal Services Agreement No. C20210071 with WSP USA Environment & Infrastructure Inc. to provide environmental expertise and consulting services to assist Skagit County in the remediation of Whitmarsh/March Point Landfill Cleanup Action Plan. This Amendment extends the term of the Agreement for two (2) additional years from December 31, 2024 to December 31, 2026, adds additional tasks described in Exhibit "A", and increases compensation by \$150,000 for a new total compensation amount not to exceed \$1,860,000. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.

- 23. Personal Services Agreement with GeoEngineers, Inc. to provide environmental consulting support on an asneeded, task assignment basis, for non-federally funded capital projects. Compensation is based on a fee schedule and shall not exceed \$150,000. The Agreement shall commence on the date of mutual execution and continue for an initial term of two (2) years with the option to renew for an additional two (2) years.
- 24. Vendor Services Agreement with Economy Fence Center to install fencing at the Guemes Ferry Terminal. Compensation shall not exceed \$9,092.92 plus applicable sales tax. The Agreement shall commence on the date of mutual execution and continue for one (1) year.
- 25. Amendment No. 3 to Local Agency A&E Professional Services Negotiated Hourly Rate Consultant Agreement No. C20220074 with David Evans & Associates, Inc. fka TranTech Engineering, LLC to provide consultant services for the Francis Road Section 3 Project #ES79000-10, Federal Aid #STPR-F294(002). This Amendment revises the Scope of Work to include attached Exhibit A.3 which provides for additional hours needed to finalize the design for the cattle crossing at Parcel #23454, and provide for additional meetings caused by permitting delays, and extends the term from December 26, 2026 to December 31, 2027. This Amendment also reflects the Contractor's name change from TranTech Engineering LLC to David Evans & Associates, Inc. Compensation is increased from \$740,974 to an amount not to exceed \$950,221. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
- 26. Personal Services Agreement with David Evans and Associates, Inc. to provide environmental consulting support on an as-needed, task assignment basis, for non-federally funded capital projects.
