Interlocal Cooperative Agreement with Washington State University for the provision of education programs provided by Cooperative Extension Services and in coordination with Skagit County Administrative Services. Compensation shall not exceed \$395,479. The Agreement is ratified to commence on January 1, 2023 and shall continue until December 31, 2023.

#### c) **BUDGET AND FINANCE:**

- 8. Amendment No. 1 to Interlocal Cooperative Agreement No. C20220486 with Port of Anacortes to award \$250,000 of Economic Development/Public Facilities Projects grant funds to support Curtis Wharf Access Improvement Project. This Amendment extends the term of the Agreement from March 31, 2023 to August 31, 2023 to complete the project that had been delayed by the review process of the Washington State Department of Ecology. All other terms and conditions of the original Agreement shall remain in effect.
- 9. Funding Agreement with Lincoln Theater to award \$25,000 of Lodging Tax funds to support facility HVAC and fire suppression as authorized by Resolution No. R20220205. The Agreement is ratified to commence on January 1, 2023 and continue until December 31, 2023.

#### d) FACILITIES MANAGEMENT:

- 10. Vendor Services Agreement with Dimensional Communications, Inc. to provide and install new AV Upgrades at the Skagit County Parker Building located at 1700 East College Way in Mount Vernon. Compensation shall not exceed \$37,002.88. The Agreement shall commence on the date of execution and continue until September 30, 2023.
- 11. Ground Lease Agreement with Skagit 911 to sublease a portion of property at 2911 East College Way in Mount Vernon at no cost for continued occupancy in a new 48' x 60' modular building. The Agreement shall commence on the date of execution and continue for 30 years.
- 12. Amendment No. 1 to Vendor Services Agreement No. C2O220103 with VECA Electrical and Technologies, LLC to provide electrician services for County Facilities. This Amendment extends the term of the Agreement by one year to continue until March 13, 2O24. Compensation remains the same and shall not exceed \$30,000. All other terms and conditions of the original Agreement shall remain in effect.

#### e) **INFORMATION SERVICES:**

- 13. Master Services Agreement and Statement of Work with CDW-Government LLC to perform a Business Impact Analysis, Disaster Recovery Planning runbook development and ad-hoc network support. Compensation shall not exceed \$153,348 including applicable sales tax. The Agreement shall commence on the date of execution and continue until December 31, 2025.
- 14. Personal Services Agreement with Nicholas Nakis for support of Skagit 21 productions. Compensation shall not exceed \$20,000 and is based on an hourly rate schedule. The Agreement shall commence on the date of execution and continue until December 31, 2026.

#### f) PARKS, RECREATION AND FAIR:

15. Vendor Services Agreement with WIN Home Inspection to provide inspection services for Parcel numbers P45245, P45194, and other County Parks properties as requested. Compensation shall not exceed \$3,000. The Agreement shall commence on the date of execution and continue for two years.

### h) <u>PUBLIC HEALTH:</u>

- 17. Lease Agreement with Bud (Lewis E.) Norris to lease storage space located at 1711 East College Way in Mount Vernon for the Syringe Exchange Program. Monthly rent shall not exceed \$939.35 plus utilities, insurance, and maintenance costs as applicable. The Agreement is ratified to commence on January 1, 2023 and continue until December 31, 2023.
- 18. Interlocal Agreement with North Sound Behavioral Health Administrative Services Organization, LLC (North Sound BH-ASO) Contract #North Sound BH-ASO-Skagit County-Interlocal-23 to provide coordination and subcontracting services for programs and services including Dedicated Cannabis Account Program, Jail Services Program, Trueblood funding, and the Co-Responder Program. Compensation to Skagit County shall not exceed \$179,765.70. The Agreement is ratified to commence on January 1, 2023 and continue until June 30, 2023.

# i) <u>PUBLIC WORKS:</u>

- 19. Vendor Services Agreement with ProScapes, Inc. to provide landscaping maintenance for divisions in Public Works to include the Conway Roundabout, South LaVenture Median, and the Solid Waste Transfer Station. Compensation shall not exceed \$39,521.58. The Agreement shall commence on the date of execution and continue for one year.
- 20. Amendment No. 1 to Personal Services Agreement No. C20220297 with Northwest Aquatic Management, LLC to provide aquatic plant management services for Lake Management District No. 2 for Lake McMurry (LMD2) to continue implementing the control strategy to monitor and manage invasive aquatic weeds such as Eurasian Milfoil and control noxious fragrant white water lilies with a mechanical harvester. This Amendment increases compensation by \$682 for an NPDES permit. Total compensation shall not exceed \$15,932. The term remains the same and shall continue until May 31, 2023. All other terms and conditions of the original Agreement shall remain in effect.
- 21. Resolution to Adopt the 2023 Annual Construction Program, Revision No. 1.
- 22. Resolution initiating County Road Projects (CRP) and assigning CRP numbers.

P41204, P41175, P41193, P134893, P41201 and P41178 granted by Skagit County to Punkin Center West, LLC, Punkin Center, LLC, JA Hamilton, LLC, and JF Hamilton, LLC. This Amends, restates, supersedes and replaces Skagit County Contract No. C20200329, a permanent, perpetual, non-exclusive, access and utility easement granted by Skagit County for the benefit of Grantee, over, upon, across, along, in, and under a portion of real property located within and

upon the Grantor's property, as described in Exhibit "A". This Amended and Restated Easement will provide utilities to access abutting properties to provide service. The Easement shall commence on the date of execution and shall continue in perpetuity.
