# b) **CORONER**:

Compensation shall not exceed \$48,000 and is based on an annual rate schedule. The Agreement is ratified to commence on January 1, 2019, and shall continue through December 31, 2022.

## c) OFFICE OF JUVENILE COURT:

7. Interlocal Cooperative Agreement with Swinomish Indian Tribal Community for the provision of Detention Facilities for Tribal Juvenile Offenders. Skagit County shall be compensated \$124 per day per juvenile. The Agreement shall commence on the date of execution and continue through December 31, 2020.

### d) PARKS, RECREATION AND FAIR:

- 8. Fairground Facilities Rental Agreement with Puget Sound Jr. Livestock Show & Sale for use of certain buildings and areas for event purposes. Compensation shall not exceed \$2,400, plus a refundable \$250 damage deposit. The Agreement shall commence on the date of execution and continue until June 6, 2019.
- 9. Trail Easement on a portion of Parcel No. P126738 granted by Raymond L. Sundstrom and Vicki M. Tisdel for the Centennial Trail Corridor Project. No compensation was expended for this easement. The Easement shall commence on the date of execution and is permanent, perpetual, and non-exclusive.

# f) PUBLIC HEALTH:

- 12. Agreement and Debarment Statement with Washington State Health Care Authority to establish Skagit County as a Core Provider which enables reimbursement for covered medical services, equipment, and supplies that Skagit County provides to eligible clients. The Agreement shall commence on the date of execution and continue until terminated.
- 13. Personal Services Agreement with Catholic Community Services to provide time-limited financial assistance to individuals and families who are homeless and determined need of short-term assistance to either acquire or sustain housing. Compensation shall not exceed \$3,000 and is based on eligibility. The Agreement shall commence on the date of execution and continue until June 30, 2019.
- 14. Personal Services Agreement with Sunrise Services to provide time-limited financial assistance to individuals and families who are homeless and determined need of short-term assistance to either acquire or sustain housing. Compensation shall not exceed \$2,900 and is based on eligibility. The Agreement shall commence on the date of execution and continue until June 30, 2019.

15. Personal Services Agreement with Pioneer Human Services to provide time-limited financial assistance to individuals and families who are homeless and determined need of short-term assistance to either acquire or sustain housing. Compensation shall not exceed \$2,900 and is based on eligibility. The Agreement shall commence on the date of execution and continue until June 30, 2019.

# g) PUBLIC WORKS:

- 16. Vendor Services Agreement with ZF Marine Propulsion Systems Miramar, LLC to complete an overhaul of the gears on the MV Guemes Ferry which includes the provision of parts and services for the ferry transmissions. Compensation shall not exceed \$34,000 plus sales tax. The Agreement shall commence on the date of execution and continue for two years.
- 17. Vendor Services Agreement with Granite Construction for the procurement of road maintenance materials such as gravel and specialty and mixed asphalt products listed in Exhibit "A". Compensation shall not exceed \$100,000. The Agreement shall commence on the date of execution and continue until March 31, 2020.
- 18. Amendment No. 1 to Construction Contract Agreement No. C20180583 with Foss Maritime Company for the 2019 Haul Out and Maintenance of the Vehicle and Passenger Ferry M/V Guemes, Project #FEHO19-1. This Amendment reflects the contractor's name change to: Foss Maritime Company, LLC. All other terms and conditions of the original Agreement shall remain in effect.
- 19. Vendor Services Agreement with Miles Sand and Gravel for the procurement of road maintenance materials such as gravel and concrete products listed in Exhibit "A". Compensation shall not exceed \$250,000. The Agreement shall commence on the date of execution and continue until March 31, 2020.
- 20. Vendor Services Agreement with Lakeside Industries for the procurement of road maintenance materials such as gravel, rock, specialty and mixed asphalt products listed in Exhibit "A". Compensation shall not exceed \$1,000,000. The Agreement shall commence on the date of execution and continue until March 31, 2020.
- 21. Amendment No. 1 to Service Level Agreement No. C20180226 with Washington State Consolidated Technology Services 2018-001 (WA Tech) for the provision of access to state-wide aerial imagery. This Amendment extends the term of the Agreement by an additional year and increases compensation by \$6,000 in order to complete imagery services. Total compensation shall not exceed \$12,000. The Agreement shall continue until April 30, 2020. All other terms and conditions of the original Agreement shall remain in effect.
- 22. Amendment No. 3 to Personal Services Agreement No. C20170133 with PND Engineers, Inc. for work related to the anticipated potential replacement of a breakwater, approach pier, gangway and floating dock serving Sinclair Island. This Amendment extends the term to June 20, 2019, in order to allow for the continued support of the Sinclair dock study. Compensation remains the same and shall not exceed \$77,833. All other terms and conditions of the Agreement and subsequent Amendments shall remain in effect.
- 23. Vendor Services Agreement with Gardner Electronics to provide services and products to outfit new Sheriff vehicles, removal of old equipment from Sheriff's vehicles and repair police package in existing Sheriff's fleet vehicles. The Agreement shall commence on the date of execution and continue for one year from the date of execution. Compensation shall not exceed \$24,000 and is based on a fee schedule.

# h) SHERIFF:

24. User Agreement with Washington State Patrol (WSP Contract No. CRD00003) to authorize the use of Livescan to Western Identification Network Automated Fingerprint Identification System in order to capture biometric fingerprint images and record related personal identifiable information. No compensation is associated with this Agreement. The Agreement shall commence on the date of execution and shall continue until services change or Agreement is terminated.

# i) SUPERIOR COURT:

- 25. Personal Services Agreement with Terry L. Dockter to provide Certified Deaf Interpreter services for Superior Court. Total compensation shall not exceed \$20,000 and is based on a fee schedule. The Agreement is ratified to commence on February 11, 2019, and shall continue through December 31, 2020.
- 26. Amendment No. 1 to Personal Services Agreement No. C20190067 with Paul Glaser to provide Certified Deaf Interpreter services for Superior Court. This Amendment ratifies the Agreement to commence on January 28, 2019. All other terms and conditions of the original Agreement, including compensation in the amount of \$20,000, and the term ending December 31, 2020, shall remain in effect.
