9. Personal Services Agreement with Gerald J. Pilolla dba IQ Direct to print, address and mail 6 x 11 cards with educational information to inform residents about an upcoming Emergency Medical Services Levy renewal. Compensation is based on a fee schedule and is estimated to not exceed \$24,000. The Agreement shall commence on the date of execution and continue until April 30, 2024.

This Amendment is necessary to implement the second phase of the compensation study involving leave and salary advancement and is ratified to begin on January 1, 2024. All other terms and conditions of the original Agreement shall remain in effect.
- 13. Memorandum of Agreement (Amendment No. 1 to Agreement No. 20230138) between Skagit County and Teamsters Union 231 (Juvenile Corrections). This Amendment is necessary to implement the second phase of the compensation study involving leave and salary advancement and is ratified to begin on January 1, 2024. All other terms and conditions of the original Agreement shall remain in effect.

f) INFORMATION SERVICES:

- 14. Amendment No. 1 to Subscription Agreement No. C20230118 with TouchPhrase Development, LLC dba Julota for a co-response software system to mitigate arrests and incarcerations by diverting clients to appropriate resources while increasing access to assistance. This Amendment updates Appendix 1 to the Statement of Work No. 1, fee schedules to add additional agencies in 2024 and 2025 to the Julota Platform for Case Management. Compensation is increased from \$60,000 to an amount not to exceed \$79,516 for 2024 and 2025. Compensation for subsequent years shall not exceed \$35,000. This Amendment amends Exhibit A to include a new section D, Data Conversation Services. Compensation is increased by an additional \$15,000 for a new compensation amount not to exceed \$45,240. g) PARKS, RECREATION AND FAIR:
