Amendment No. 1 to Interlocal Cooperative Agreement No. C20220237 with Washington State University (WSU) to award \$250,000 of Economic Development/Public Facilities Projects grant funds to support Phase 2 of the Plant Growth Facility Project. This Amendment extends the expiration date and deadline for substantial completion of the project from March 30, 2023 to March 30, 2024. This Amendment will allow WSU to complete construction of Phase 2 of the Plant Growth Facility Project. Compensation remains the same and shall not exceed \$250,000. All other terms and conditions of the original Agreement shall remain in effect.
- 5. Resolution to call for a public hearing to consider testimony regarding amending the 2023 Skagit County Budget. The public hearing is scheduled to take place on Tuesday, March 28, 2023, at 11:15 a.m., or as soon thereafter as possible in the Skagit County Commissioners Hearing Room located at 1800 Continental Place in Mount Vernon. c) EMERGENCY MEDICAL SERVICES:

6. Personal Services Agreement with Medical Education and Training Industries, LLC to provide ALS skills labs, Advanced Airway Management classes and mutually agreed upon courses or EMS Skills Evaluation. Compensation is based on a fee scheduled and shall not exceed \$56,000. The Agreement is ratified to commence on February 1, 2023 and continue until December 31, 2023.

d) FACILITIES MANAGEMENT:

7. Personal Services Agreement with Culligan Northwest to provide hot/cold water dispensers and weekly bottled water delivery at the County Courthouse (205 West Kincaid Street, Mount Vernon), Administration Building (700 South 2nd Street, Mount Vernon) and Courthouse Annex (603 South 3rd Street, Mount Vernon). Compensation is based on a fee schedule and shall not exceed \$20,000 including applicable taxes. The Agreement shall commence on April 1, 2023 and continue until March 31, 2026.

e) PARKS, RECREATION AND FAIR:

8. Amendment No. 1 to Personal Services Agreement No. C20220379 with Washington Trails Association to provide trail maintenance volunteers, tools, and crew leaders to train them in the techniques of trail maintenance and construction for ten (10) work events at Sharpe Park/Montgomery-Duban Headlands, and other Skagit County Parks as assigned. This Amendment adds expenses related to five (5) additional events at Sharpe Park/Montgomery-Duban Headlands and other Skagit County Parks as assigned. Compensation is increased from \$14,000 to an amount not to exceed \$21,000. The term remains the same and shall continue until December 31, 2023. All other terms and conditions of the original Agreement shall remain in effect.

f) PUBLIC HEALTH:

- 9. Personal Services Agreement with Little Mountain Counseling to provide mental health consultation to the Nurse-Family Partnership (NFP) team regarding the psychosocial needs of pregnant women and families with infants and toddlers. Compensation based on a fee schedule and shall not exceed \$3,000. The Agreement is ratified to commence on January 12, 2023 and continue until December 31, 2023.
- 10. Personal Services Agreement with Hand Crank Films to help Skagit County engage, educate, and inform the community about the North Star Project and convey critical messages about homelessness and behavioral health. Compensation is based on a reimbursement for services schedule and shall not exceed \$30,000. The Agreement shall commence on April 1, 2023 and continue until June 30, 2023.
- 11. Amendment No. 1 to Personal Services Agreement No. C20220573 with Mount Baker Presbyterian Church to plan, manage, and operate a temporary, seasonal shelter at the Community Blessings Initiatives Center located at 44942 State Route 20 in Concrete. This Amendment increases compensation from \$110,500 to an amount not to exceed \$124,155 and extends the term from March 31, 2023 to April 30, 2023. All other terms and conditions of the original Agreement shall remain in effect.

- 12. Resolution rescinding partially executed Skagit County Agreement No. C20230084 Data Sharing Agreement (DSA) with the State of Washington Department of Health (DOH) to access COVID-19 vaccination data for Skagit County, DSA Agreement No. 20-SKG-COVIDVax-0. Agreement No. C20230084 needed to be corrected, the final corrected version of the Agreement will be rerouted for signature.
- 13. Resolution authorizing Chair Ron Wesen to electronically sign the submission of Amendment No. 11 to Skagit County Contract No. C20210602 with the Washington State Department of Health (DOH Contract No. CLH31025) to increase funding by an additional \$8,800 for a total contract amount of \$5,848,121 to support Public Health's programming.
- 14. Amendment No. 11 to Skagit County Contract No. C20210602 with the Washington State Department of Health (DOH Contract No. CLH31025) for the delivery of public health services in Skagit County. This Amendment amends Statements of Work for various Public Health programs. Compensation to Skagit County is increased by an additional \$8,800 for a new total compensation amount not to exceed \$5,848,121. The term remains the same and shall continue until December 31, 2024. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
- 15. Agreement with Skagit Valley College radio station KSVR-FM for the provision of English and Spanish radio announcements regarding opioid awareness and prevention. Compensation is based on a rate schedule and shall not exceed \$900. The Agreement shall commence on March 13, 2023 and continue through May 31, 2023.

g) PUBLIC WORKS:

16. Interlocal Cooperative Agreement with the Port of Skagit to facilitate the County providing the Port with partial limited funding for the Port to perform work to maintain native riparian vegetation along Big Indian Slough to benefit riparian enhancement in the vicinity of the Port's property. Compensation is based on a portion of the funds required for the project and shall not exceed \$7,000. The Agreement is ratified to commence on January 1, 2023 and continue until December 31, 2024.
